BACKGROUND: The Law Enforcement Congressional Badge of Bravery

(CBOB) was established by Congress in 2008 to honor exceptional acts of bravery in the line of duty by federal, state, and local law enforcement officers. The program is administered by the DOJ's Bureau of Justice Assistance and medals are awarded annually by the U.S. Attorney General and presented by the recipients' Congressional

representatives.

On October 16, 2013, Officer Rodriguez was a customer in a Reno Bank of America when an armed robber entered, demanded money, and then fatally shot 80-year-old Charles "Bob" Sperry, who attempted to intervene in the robbery. The robber than fled on foot.

Officer Rodriguez, off-duty and unarmed, was concerned that the suspect might escape or further escalate the

situation when Reno Police Department officers arrived. He followed the suspect to a local bus depot and placed him in a "carotid hold," disarming him and holding him down until responding officers took him into custody.
